Note:-

- 1] If Division Bench-I is not available, then urgent fixed date cases of "List-1" only shall be listed before the Division Bench-II and such other cases of that Bench, which are directed by Division Bench-II shall also be listed.
- 2] If Division Bench-II is not available, then urgent fixed date cases of "List-1" only shall be listed before the Division Bench-III and such other cases of that Bench, which are directed by Division Bench-III shall also be listed.
- 3] In case, Division Bench-III is not available, then urgent fixed date cases of "List-1" only shall be listed before Division Bench-II and such other cases of that Bench, which are directed by Division Bench-II shall also be listed.
- 4] When number of cases are connected with each other, the matters shall be listed before the Judge having the roster to hear the leading/main case. In case, the connected cases are fixed for in different dates, then the connected cases shall be listed on the date, which is earlier.
- 5] All the cases which are already assigned to any of the Single or Division Bench, shall be listed as per Roster if the same is not exception to that Bench.
- 6] In case, the order has been passed by a Division Bench and one Judge has retired or is no longer in the High Court, then the contempt petition shall be listed before the Bench in which the other Judge is a Member.
- 7] In case, both the Judges who passed the order are not available, then the contempt petition shall be listed before regular Division Bench.
- 8] In case, the Judge who passed the order is not available, then the contempt petition shall be listed before the regular Single Bench.
- 9] Final hearing cases for each Court will be listed Court-wise (Bench-wise) without mentioning the names of Hon'ble Judge/Judges who may preside those Benches.
